3. MINUTES OF THE MEETING

Prof. Dr. Rame Vataj, Rector of the University of Prizren "Ukshin Hoti", had a welcome speech on the importance of "Financial autonomy and accountability of the University of Prizren"

Mjellma Carabregu, WUS Kosova introduced the participants with the main elements of the White Paper concerning "Financial autonomy and accountability of the public higher education institutions".

The following presentations were delivered during the workshop in the context of the University of Prizren "Ukshin Hoti":

- "Accreditation, autonomy and financial accountability of the public higher education institutions in Kosova", Kosova Accreditation Agency
- "Financial Autonomy and Accountability at the University of Prizren Ukshin Hoti", Mr. Halim Haziraj, Officer for Budget and Finance
- Prof. Dr. Gani Gjini, University of Prizren "Ukshin Hoti":

- Mjellma Carabregu, WUS Kosova:

Conclusions of as a result of the discussion during presentations:

- Importance of fund generation for the University of Prizren "Ukshin Hoti", due to its limited budget.
- The interference of the Government in the fund generation, by cutting the students' fees should be done only via consultation with all public higher education institutions, not as a one-way decision.
- Existence of financial bureaucracy among the small units and Rectorate.
- Lack of experiences in the budget planning in the UPz, by the specific faculties.
- Internal Auditor, although employed for 2 years now, he has not been given competences by the relevant ministries (Ministry of Finance and Ministry of Education, Science and Technology of Kosova) to perform his duties. The UPz considers of utmost import to authorize Internal Auditor in order to execute his/her duties, which would contribute in the enhancement on implementation of different financial regulations and overall financial management of UPz. Thus, further efforts on lobbying should be put by UPz and its stakeholders to the MEST and Ministry of Finance.
- The provided access to the FreeBalance System has contributed very much, to more easily handle the payment issue. This has enabled that UPz conducts the payments on its own, by not having to send all the files (invoices and the purchase order) for execution in Prishtina, at the MEST Finance Department. This has also contributed to increase the responsibilities to the University of Prizren "Ukshin Hoti" on financial management of the institution and execution of its budget.
- The main elements from the presentations and discussions have been incorporated in the Action Plan, as well.

In the end of the workshop, the UPz staff participated in an exercise concerning evaluation of autonomy at UPz based on the dimension of the European





University Association. Its results are part of the Minutes and published under project website – Resources.
